**CHURCH IN THE SON FINANCIAL POLICY****Contributions Policy:**

Your Global Mission trip balance must be paid in full by the final payment deadline or you will not be included on the trip. Each trip has installment plans setup for your convenience, in the event the deadlines are not met you may be asked not to participate on the trip.

If due to a natural disaster or a global conflict, etc. of any significance and Church In The Son cancels a Global Mission trip, and if the final team member payment balance is not submitted by the final date, or if the team member makes the conscious decision to withdraw from a trip, the following actions will take affect:

1. A non-refundable administration fee of \$100.00 will be assessed.
2. Any payments that have been used towards the purchase of a said mentioned trip expenses, (e.g., airfare, accommodations, insurance, etc.) are non-refundable, unless otherwise stipulated in the contractual agreement.
3. Any payments that have been donated by a third party towards any trip will not be refunded to you or the third party. Funds will be moved to the Missions General funds account for the trip. If the trip is canceled, all third-party funds will be moved to the Global Missions fund, until further directions are given by the said third-party person.
4. Any payments made by a trip member will be refunded upon written request after the first three clauses have been satisfied. Upon written request, the leftover monies in the team member's account can be designated to any of the following areas:
  - a. Missions General Contributions funds of a team members trip
  - b. Another trip member
  - c. Ministry as a gift

**Overage Funds Policy:**

If you raise over and above the required trip cost, the excess funds will be moved to the Missions General Contributions funds account for your trip unless otherwise designated by you. Excess funds can also be applied to another team members account, applied to the Missions General Contributions funds of your trip, or refunded to you. Third party donations will be moved to the Missions General Contributions funds account; not refunded to you.

**CHURCH IN THE SON FINANCIAL FAQs****Question 1:**

I personally contributed and/or collected donations from a Third Party over and above the total trip cost. Can either one of those funds be refunded to me or the Third Party?

**Answer 1:**

No Personal Funds will be refunded, but they can be transferred to a future mission trip.

Any over and above funds collected from a Third Party will go directly to "General Contributions," which then will be distributed to the local missionary.

\* You are responsible for keeping records of all Personal Funds contributed, thus there should not be any overage of donations unless it was indicated by you that the funds should be allocated elsewhere.

**Question 2:**

I did not make the payment deadline to purchase airline tickets, can I buy my ticket separately from the team?

**Answer 2:**

The Global Reach mission's department utilizes a travel agency to purchase group tickets, this is to ensure that the entire team travels together for safety, as well as team unity. For these reasons, it is not permitted for any team member to make separate travel arrangements.
